# ADMISSIONS INFORMATION

# Who should apply to the Tepper School?

okyo, sapar Successful Tepper candidates come from a wide variety of backgrounds and profiles. We encourage interested candidates to focus on the range, rather than the mean, when reviewing class profile and considering whether or not they should apply. For example, half of our students have GMAT scores below the average, and although most students have between 2 and 8 years of professional experience, there are several that joined Tepper directly after their undergraduate study or that have more than 8 years of experience. Although our most recent class has a high proportion of students from engineering/science backgrounds, we are seeking candidates from all academic disciplines, and in a typical year, half of our students come from non-technical backgrounds. You simply don't need to be an engineer to achieve great things at Tepper. We have many students currently studying at Tepper who were initially concerned about their chance of being admitted, that have been successful---and with many receiving merit scholarships.

The only sure-thing in the admission process is that you cannot get in if you don't apply! If you have any questions regarding your candidacy, the admissions team would be happy to speak with you. Feel free to contact us to arrange a meeting with one of our counselors.

# What are the Tepper School admissions process requirements?

To be considered for admission, you need to submit a complete application portfolio that includes the following documents: application form, official transcripts from each college or university attended at both the graduate and undergraduate level, two letters of reference, official GMAT scores, official TOEFL scores (for applicants whose native language is not English), affidavit of financial support (only for students who are not U.S. citizens or permanent residents), current resume, employment record, required essays, and application fee. # Do you weigh some parts of the application more strongly than others?

No single component in the application portfolio is more important than any other. A particular weakness may be successfully offset by strengths in other areas.

# If I am not admitted to the program, can I re-apply?

Yes. Applicants who are interested in reactivating their application should submit a formal letter requesting this action be taken on their application. Visit our <u>Re-applicants</u> page for more information.

# If I am re-applying, do I need to submit a new application?

No. If you have submitted an application for the MBA program within the past two years, you don't need to submit an entirely new application. Please visit our <u>Re-applicants</u> page for a checklist of materials and information needed in order to re-apply.

### May I receive my decision over the phone, via e-mail or fax?

Our primary means of communicating with all candidates is via email, so please make sure to update your online profile if your email address changes. All admission decisions are released to candidates using our online application system. You will be notified by email when your decision is ready for viewing and you will need your login/password to access your admission decision. A hard copy of admission offer letters will also be mailed to the postal address listed on your application.

### QUALIFICATIONS

#### How are candidates assessed for admission?

Though our standards are high and our admissions process is very competitive, our ideal student does not fit a rigid profile. We welcome students from diverse academic, professional and personal backgrounds and seek exceptional individuals who have made an impact on whatever path they have chosen. We examine all components of your MBA application to gain an understanding about you as a candidate. Our admissions committee is interested in your potential for academic success at the Tepper School and professional success in the future. We evaluate your reasons for applying to the Tepper School, as we want to be sure that your background and goals are consistent with our strengths. We seek students who are highly motivated, tenacious, self-directed and innovative and who demonstrate a strong work ethic. Personal competencies such as communication, interpersonal, teamwork and leadership skills are among other key considerations. Non-native English speakers must be skilled and confident when speaking, listening, reading and writing in English, to ensure that they can participate fully in our learning environment.

#### Do I have to have post-undergraduate work experience?

No, post-undergraduate work experience is not a prerequisite for admission. We seek diversity in all dimensions, including from "candidates without any post-undergraduate work experience" to "candidates with 8 or more years of work experience."

### What consideration is given to post-undergraduate work experience?

Candidates with post-undergraduate professional experience have, everything else equal, a better chance for admission, but we welcome applications from exceptionally talented and motivated individuals who may not have significant experience. Candidates with no or limited professional experience must be strong in other aspects of their MBA application to offset the lack of experience.

### On average, how many years of full-time work experience do most accepted candidates have?

Most of our MBA students fall in a range of 2 to 8 years of post-undergraduate professional experience. For the class entering in 2011, the median years of full-time work experience is 4.5 years. However, the impact a candidate has made on her company, growth in responsibility over time, leadership experience and other factors are used when evaluating experience, not simply the number of years.

### Are transfer credits accepted?

No, the business school does not accept any transfer credits into the MBA program.

### What is the average G.P.A?

For students entering the MBA program in 2011, the average was 3.35. However, the admissions committee examines the applicant's entire academic record, not just the G.P.A. We look at grade trends, the major, courses taken as well as the rigor of the program and institution.

# Am I required to take the GMAT/GRE? When should I take the GMAT/GRE? What is the average GMAT/GRE score? Is there a minimum GMAT/GRE score required to apply to the Tepper School of Business?

All MBA applicants must complete either the GMAT or the GRE. Since both tests are now offered year round, the examination can be taken at any time. However, you should take the test no later than the application deadline for which you are applying. The average GMAT score for last year's full-time entering class was 686, with most successful applicants scoring 600 or higher. This is the second year that we will be accepting GRE scores. As such, there is not yet a GRE average. There is no minimum score required for either test. Review our <u>class profile</u> for details.

#### What if I take the GMAT/GRE more than once?

When reviewing your application, our admissions committee always uses your best GMAT/GRE score at the time of application.

#### What is the Tepper School code for the GMAT?

Simply Select Carnegie Mellon University, then the Tepper School of Business. You will have the option of selecting the Full-Time MBA Program or the Part-Time MBA Program. Use your best judgment here in terms of which program you plan to apply. Scores for either program will be sent to our office, so it is okay to switch program options at a later date.

#### What is the average TOEFL?

A minimum score of 600 PBT/250 CBT/100 IBT is required for international students entering the MBA program.

#### May I waive the TOEFL/IELTS/PTE?

International students who hold a degree from an institution where the primary language of instruction was English are eligible to waive the TOEFL/IELTS/PTE. Applicants should send a letter requesting the waiver along with their application packet.

#### May I receive an application fee waiver?

Fee waivers are granted in some circumstances. To request an application fee waiver, you need to submit a letter with your application detailing why you should be considered for the waiver. Our admissions committee will review requests on an individual basis.

#### Are there any pre-requisites?

MBA applicants must hold the equivalent of a Bachelor's degree and demonstrate a strong aptitude for mathematics. Entering MBA students must have completed one semester of college calculus and either statistics, calculus II or linear algebra before matriculating. Candidates who do not meet the math requirements may be admitted with the provisions that they complete the necessary math courses prior to joining the program. We offer an Advanced Math Skills Review Workshop (AMSW) to students who have studied calculus, but would like a review before classes begin.

### Do you accept 3-year undergraduate degrees (i.e. B.Com)?

We will consider applicants who hold a 3-year undergraduate degree. In general, due to the highly competitive nature of our applicant pool, candidates with additional education beyond their 3-year degree are more competitive.

### ADMISSIONS PROCESS

# Will I be notified of my application status?

Applicants who use our on-line application system are able to monitor their application status on-line. To check on the status of your application and supporting documents, simply log into the application system of our <u>on-line application provider</u> (the same link used to submit the application). The first page that loads will provide the status of the application as well as indicate which supporting documents have been received.

### Why have you not received my supporting documents?

There are several likely reasons why supporting documents might take some time to show on the on-line status. The most common explanations (and steps you can take in advance to ensure arrival of your supporting documents) are:

- 1. Time: Due to the large volume of mail that we receive during our application deadlines, please allow 10-14 days for your application materials to be processed. As our office opens mail and processes the supporting documents, your on-line status will be updated.
- 2. Inconsistency in the Applicant's Name as Represented in Supporting Documents: We recommend that you ensure that all materials arriving for your application have consistency in your name. # CURRICULUM

### What makes the mini-semester system unique?

The <u>mini-semester</u> system splits the typical semester in half, creating four mini-semesters per academic year. This system allows students the opportunity to gain exposure to a wide range of topics, and many unique courses. This format allows students flexibility to choose from among more than 120 electives in 13 areas of concentration.

# What are the degree requirements for the MBA Program?

All degree candidates enrolled in the MBA Program complete a required core curriculum in addition to 90 units of electives for a total of 192 units (note, students pusuring a dual degree may have a different total unit requirement). Most business school subjects range from 6 to 12 units based on an approximation of weekly class hours, and outside preparation time. # What are the different concentrations and tracks in the MBA program?

Students can currently choose from 6 tracks, including the General Management Track, which allows students to choose from 13 different concentrations.
